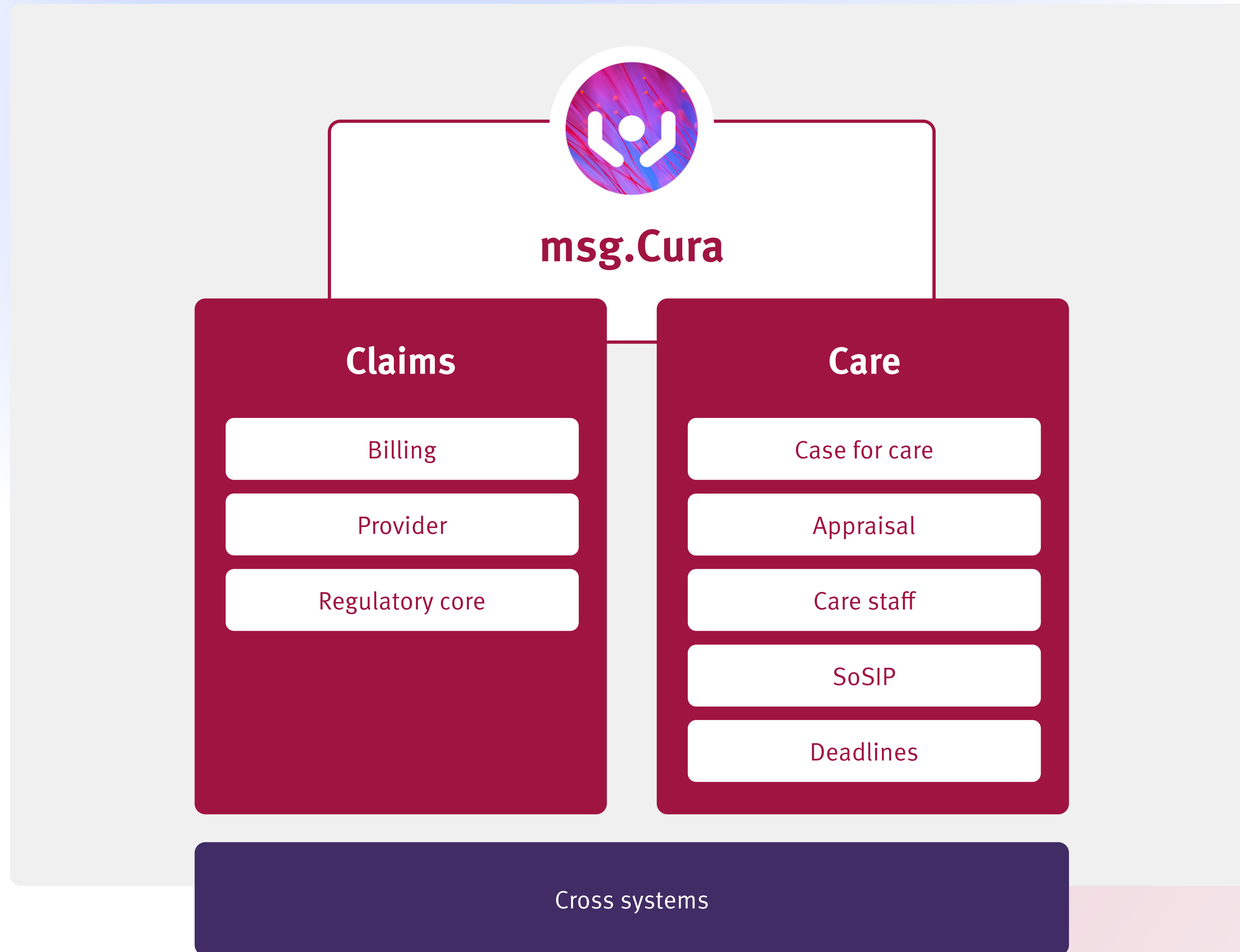




## Complete solution for all aspects of care claims management

## ● Managing transactions related to care needs

Our powerful standard software msg.Cura is specially designed for mandatory private care insurance (PPV), which is standardised across the association and also offers a standardised framework for the mapping of supplementary care insurance. In this context, all necessary transactions (appraisal commissioning, aid management, care billing, pension insurance notifications, etc.) are supported and continuously adapted to the latest amendments to legislation.

We monitor legislative proposals on a daily basis in order to be able to react quickly in our product. Are you subject to a regulation regulating assistance for civil servants? msg.Cura has integrated this as well as the PKV rules (Verband der Privaten Krankenversicherung / Private Health Insurance Association).

msg.Cura maps the workflow of all process steps relating to a case of a person in need of care in an integrated case management system. In the area of care billing, the entitlement is derived based on the data of the case of a person in need of care and the tariffs insured during the billing period. On request, the invoice data can be checked against existing remuneration agreements. Almost all the benefits provided for in the context of compulsory care insurance are supported by automatic calculation rules.

You leave standard tasks to msg.Cura. From recurring payment of care benefits (and also home emergency calls, flat rate for residential groups, consumables and full inpatient care), to monitoring of consultation and responding

to deadlines that have elapsed: msg.Cura offers automated procedures to make your day-to-day life easier.

With msg.Cura, you can directly connect to MEDICPROOF GmbH (care appraisal) and integrate the ZABAS care module (review pension contracts; a product of our subsidiary Global Side GmbH). On request, msg.SoSiP can be embedded directly in the processing process of cases of people in need of care for the billing of social security contributions for carers. No additional integration is required and you can use these function blocks without any media interruptions.

msg.Cura defines standard interfaces through which our software solution can be integrated into your existing system landscape. From input management to printing and payment, your existing systems can be connected. You benefit from the added value of standard care software without having to completely redo your system landscape.

## ● Fit for the cloud

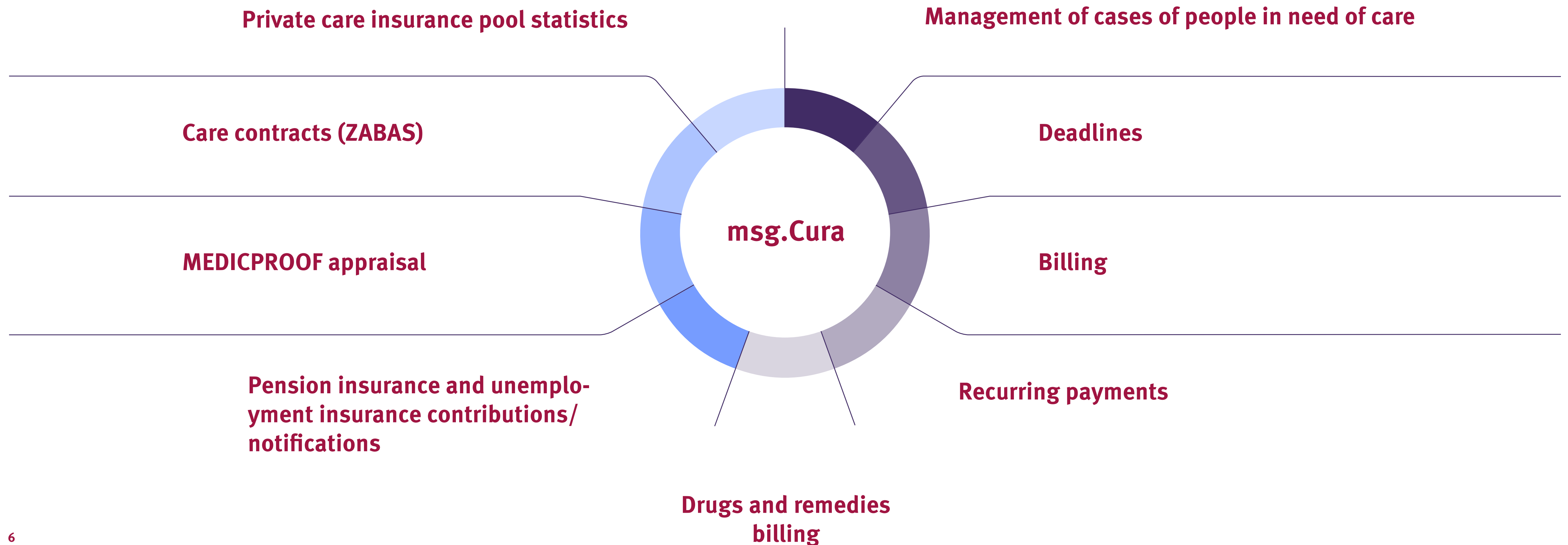

## ● Functional characteristics

- Management of cases of people in need of care: all entitlements are clearly presented as cases of people in need of care.

- Deadlines: follow-ups are shown using our powerful appointment module (workflow with preconfigured specialist appointment types)
- Billing: predefined loss adjustment model for care benefits as part of compulsory care insurance
- Recurring payments: care benefit, daily care benefit (supplementary care insurance), home emergency calls, flat rate for residential groups, flat rate for consumables and full inpatient care can be paid automatically per batch
- Care aid management: drugs and remedies catalogue is preconfigured in accordance with the care aids directory
- Pension insurance/unemployment insurance contributions/notifications: msg.SoSiP is embedded in the management system of cases of people in need of care so that pension insurance and unemployment insurance contributions for carers can be processed directly during the case of a person in need of care
- MEDICPROOF appraisal: expert reports can be commissioned directly from procedures case of a person in need of care. Appraisal results are (partially) processed automatically.
- ZABAS care is integrated on request for invoice verification and recurring payment of full inpatient care benefits
- Private care insurance pool statistics: billing and appraisal data are prepared for the pool statistics. Our ETL process for creating the data exchange formats can also be provided on request
